SUBJECT: SEABROOK STATION-COMPLETION OF SERVICE WATER SYSTEM PROBLEMS  
AFFECTING SAFETY-RELATED SYSTEMS, GENERIC LETTER 89-13  
(TAC NO. M74059)

The purpose of this letter is to inform you we have completed our review of your responses dealing with the subject matter and they appear to be adequate. We are closing this issue.

On February 9, 1990, you provided your initial response to the subject generic letter. In that submittal, you provided specific commitments in response to the five actions recommended in the generic letter.

In April 4, 1990, the NRC issued Supplement 1 to Generic Letter 89-13. The supplement provided interpretations of the recommendations in the original letter. As a result of an interpretation in Supplement 1, you increased the scope of your commitment regarding Recommended Actions IV and V.

In a letter dated July 13, 1990, you committed to include the Primary Component Cooling Water (PCCW) heat exchangers in your programs for those actions.

In a letter dated September 24, 1990, you provided amplification of selected portions of your response. Specifically, initial tests in response to Recommended Action II had been completed and baseline data had been collected, analyzed and compared to the design performance requirements. Additionally, a program for review of the PCCW system was outlined.

In a letter dated October 18, 1991, you reported the results of your review of the PCCW system and indicated that implementation of all actions required by Generic Letter 89-13 were completed. You reaffirmed that all implementation

was complete in a letter dated November 4, 1991, on completion of first refueling outage commitments.
