The inspection included a review of activities authorized for the Comanche Peak Steam Electric Station, Units 1 and 2. Areas examined during the inspection included plant status, followup on previously identified items, licensee event report followup, onsite followup of events, operational safety verification, maintenance observation, and surveillance observation. Within the scope of the inspection, no violations or deviations were identified.

One unresolved item is identified in paragraph 7.1 of the enclosed report. The item involves the status of work request tags identified in the plant but not readily traceable through the work control program.
