This refers to the routine safety inspection conducted by Mr. S. K. Orth of this office on April 20 - 24, 1992, of activities at the Perry Nurkar Power Plant, authorized by NRC Operating License No. NPF-58, and to the assession of our findings with Messrs. R. Stratman, B. Beyer, E. Riley, zea others of your staff on April 24, 1992.

The enclosed copy of our inspection report identifies areas examined curing the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

No violations of NRC requirements were identified curing the course of the inspection.

This inspection identified an unresolved item concerning the operability of the ventilation systems in the Emergency Operations Facility and Technical Support Center. During the inspection, your staff did not have the necessary information to explain deviations from the testing procedures described in Section 3.b of the enclosed inspection report No. 50-440/92008(DRSS). We request a written response within 30 days describing the reasons for the deviations.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC Public Document Room.
