SUBJECT: NRC INSPECTION REPORT 50-482/95-25 AND NOTICE OF VIOLATION

This refers to the inspection conducted by Messrs. J. F. Ringwald, F. L. Brush, D. L. Solorio, W. M. McNeill, and Ms. J. L. Dixon-Herrity of this office on November 19 through December 30, 1995, at the Wolf Creek Generating Station facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Based on the results of this inspection, the NRC has determined that one violation of NRC requirements occurred. The violation is cited in the enclosed Notice of Violation (Notice) and the circumstances surrounding it are described in detail in the subject inspection report. This violation of a containment spray surveillance test procedure is of concern because the use of "not applicable" markups, although made in a manner consistent with your administrative procedures, altered the intent of the surveillance test procedure resulting in unexpected system operation and damage to the suction pressure gauge.

One unresolved item was identified concerning radiography. This matter is discussed in Section 6.1 of the enclosed inspection report.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. Your response may reference or include previous docketed correspondence, if the correspondence adequately addresses the required response. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter, its enclosure(s), and your response will be placed in the NRC


