SUBJECT: NRC INSPECTION REPORT 50-285/95-23

This refers to the inspection conducted by A. D. McQueen and R. E. Lantz of this office on December 18-21, 1995, at the Fort Calhoun Station facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.

An exercise weakness identified during the inspection is discussed in Section 4 of the enclosed inspection report. The weakness involved a failure to make a timely notification of an alert to off-site response agencies.


Exercise weaknesses according to 10 CFR Part 50, Appendix E.IV.F.2.g, are inspection findings that need to be corrected by the licensee. You are requested to provide this office with a description of your corrective measures and your schedule for completing these actions within 30 days after receipt of this letter.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
