Westinghouse letter NTD-NRC-95-4534, dated August 18, 1995, submitted topical report WCAP-14442, "AP600 Core Makeup Tank Level Instrument Test Data And Evaluation Report". The report documents the performance of CMT level instrumentation based on data obtained during the AP600 testing program.

Our technical staff has reviewed this report and determined that the informotion is insufficient to support a safety evaluation. The report was based on a CMT test program primarily directed to obtain thermal-hydraulic data and was not specifically developed for evaluating the CMT level instrumentation. Since the tests performed were not intended to verify the performance and direct application of the CMT level instrumentation to the AP600 plant configuration, Westinghouse should commit to perform additional tests to verify the applicability and reliability of the level instrumentation. A commitment to provide this testing as a Tier 1/ITACC item would be appropriate.
