SUBJECT: CLOSEOUT OF REGION III PORTION OF THE LICENSE FILE FOR LICENSE "DS. SUB-023, C-5131, AND C-3691 FOR THE HAYNES STELLITE COMPANY, KOKOMO, INDIANA

The subject terminated licenses were forwarded to Region III for followup as part of the ORISE Terminated Sites Review because they lacked information regarding the adequacy of the site decontamination when the licenses were terminated. Three locations of use were identified with these files: 1020 Park Street, Kokomo, Indiana; 1509 North Washington Street, Kokomo, Indiana; and 30 East 42nd Street, New York, New York.

The site at 1509 North Washington Street, Kokomo, Indiana, was inspected and addressed in Inspection Report No. 040-00683/95001(DNMS) dated January 9, 1996.

The site at 1020 Park Street, Kokomo, Indiana, was inspected and addressed in Inspection Report No. 999-90003/95002(DRSS) dated March 15, 1995 (attached). This inspection was conducted in regard to Union Carbide Corporation License Nos. STB-954, STB-994, SMB-898, SMB-994 and 13-01106-02. This inspection was also conducted in response to the ORISE Terminated Sites Review, but did not specifically address License Nos. SUB-023, C-5131, C-3691. Because this site had already been inspected in March 1995, and the isotopes of interest for the Haynes Stellite Company were similar and would have been identified if present during that inspection, no additional inspection was required in response to assessing the Haynes Stellite Company License Nos. SUB-023, C-5131, and C-3691.

Following issuance of this memo, the license files for these licenses will be forwarded to NRC Region I for evaluation of the site at 30 East 42nd Street, New York, New York.

Based on the results of our evaluations, Region III considers these files closed and intends no further action regarding this issue for the above two sites in Kokomo, Indiana.
