Harris of this office on March 7 - April 21, 1992, at the Vermont Yankee Nuclear Power Station, Vernon, Vermont. The results of the inspection were discussed with Mr. D. Reid at the conclusion of the inspection.

A strong orientation towards nuclear safety was reflected by your staff's professional approach in conducting outage activities. We observed a frequent and effective presence of your supervisors and managers in the field, which contributed to a safe and successful outage.

Although two violations involving a missed technical specification surveillance test of standby liquid control tank boron concentration and incomplete fitness for duty tests were reviewed by the inspectors, these violations were not subject to enforcement actions because your efforts in identifying and correcting the violations met the criteria specified in Section VII.B.(1) of the NRC Enforcement Policy.
