SYNOPSIS

On May 8, 1990, the U. S. Nuclear Regulatory Commission (NRC) Regional Administrator, Region III, requested that an investigation be initiated to determine if the Detroit Edison Company (DECo), Fermi 2 Power Plant (Fermi 2), senior management discriminated against the Assistant Director of Nuclear Security (ADNS), for reporting concerns to the NRC. The alleged discrimination for contacting the NRC allegedly occurred when the licensee failed to promote the ADNS to Director, Nuclear Security (DNS), and instead reassigned him to a special project of rewriting nuclear directives in the DECo Corporate Headquarters Office.

The Office of Investigations' investigation substantiated the ADNS had not been promoted to the position of DNS and had been reassigned to a special project of rewriting nuclear security directives in the corporate office; however, the investigation did not substantiate the allegation that DECo Fermi 2 senior management had discriminated against the ADNS as a result of his contact with the NRC.
