Gentlemen:

This refers to the inspection conducted by E. Girard of this office on December 4 - 8, 1995. The inspection included a review of activities authorized for your Hatch facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report.

This inspection evaluated your completion of Generic Letter (GL) 89-10, "Safety-Related Motor-Operated Valve Testing and Surveillance." The inspection consisted of interviews with personnel and selective examination of related documentation. The inspection identified several issues that remain to be resolved and we request that you provide a written response to aid in their resolution within 30 days of receipt of this letter. The issues relate to Inspector Followup Items 50-321, 366/95-02-01 and -05 and are described in the enclosed inspection report. They involve assumptions that were used in setting valves that were not dynamically tested and the scope of valves and valve functions included in your GL 89-10 program.

Within the scope of the inspection, violations or deviations were not identified.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.
