Dear Mr. Fici:

This refers to the inspection conducted on December 11-15, 1995, at the Columbia Nuclear Fuel Plant, and a subsequent telephone conversation on January 10, 1996, between J. Heath, C. Sanders, and W. Goodwin of your staff and C. Bassett, A. Gooden, and E. Testa of my staff. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

Within the scope of the inspection, violations or deviations were not identified.
