## Gentlemen:

In accordance with 10 CFR 50.54(p)(2) and 50.4(b)(4), we are transmitting the original and three copies of Revision 31 to the Industrial Security Plan for the H. B. Robinson Steam Electric Plant (HBRSEP), Unit No. 2. This revision was made effective on November 28, 1995, and in accordance with 10 CFR 50.54(p)(2), is required to be submitted to the NRC by January 29, 1996.

We have reviewed the changes and determined that they do not decrease the safeguards effectiveness of the plan. The revision incorporates changes associated with implementation of the Biometrics Hand Geometry (BHG) System at HBRSEP, Unit No. 2. Implementation of this system is acceptable as a result of an exemption to 10 CFR 73.55(d) granted by NRC letter dated December 20, 1994.
