Subject: Submittal of Fermi 2 Physical Security Plan (Revision 19)

The purpose of this letter is to submit the Fermi 2 Physical Security Plan (Revision 19) in accordance with 10CFR50.54(p)(2). Chapter 3 of Revision 19 incorporates implementation of the access authorization program at Fermi 2 as required by the Final Rule on 10 CFR Part 73 (Reference 2) and as committed by Detroit Edison in Reference 3. All elements of Regulatory Guide 5.66 have been implemented to satisfy the requirements of 10CFR73.56.

In addition, Chapter 1 has been revised to update the reporting relationships of Fermi 2 Nuclear Security Organization. A revision summary of the changes made by Revision 19 to the Fermi 2 Physical Security Plan is provided. Only Chapters 1 and 3 as changed by Revision 19 are being submitted. All changes to the text are highlighted (shaded). The changes made under this revision do not decrease the effectiveness of the Fermi 2 Physical Security Plan.


