This letter refers to the safety issues program inspection of your access authorization program conducted by Messrs. D. F. Limroth and G. C. Smith of this office at the Oyster Creek Nuclear Generating Station from November 27-30, 1995. Areas examined during the inspection are identified in the enclosed report. The inspection consisted of interviews and examination of selected procedures and representative records. Our findings were discussed with Mr. Levin and other members of your staff by Mr. Limroth at the conclusion of the inspection.

The inspectors determined that you had implemented an effective program that provided high assurance that individuals granted unescorted access were trustworthy and reliable and did not constitute an unreasonable risk to the health and safety of the public, including a potential to commit radiological sabotage.

No safety concerns or violations of regulatory requirements were identified; no response to this letter is required.
