Dear Mr. Querio:

This refers to the inspection conducted on October 14 through December 1, 1995, at the LaSalle facility. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the inspection, findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

No violations of NRC requirements were identified during the course of this inspection. However, we continue to be concerned with the poor material condition at LaSalle. Rework and human performance issues impacted the implementation of your material condition improvement plan. We encourage you to resolve these issues.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practices," a copy of this letter and its enclosure will be placed in the NRC Public Document Room (PDR). We will gladly discuss any questions you have concerning this inspection.
