Dear Mr. Zugger:

The plant heating boiler was started on August 5, 1984, due to simultaneous outages of both nuclear units. A blowdown sample taken August 6, 1984, at 0020 hours was analyzed and found to have an iron concentration of 1.40 ppm. The iron level most likely is the result of infrequent use of the boiler. A backup sample was taken August 6, 1984, at 0755 hours and analysis indicated 0.47 ppm iron concentration.

An NPDES modification which exempts the plant heating boilers from iron and copper limits was approved at a meeting of the Michigan Water Resources Commission on March 21, 1979, although the staff has never formally modified the permit to reject this administrative action.
