SUBJECT: EXAMINATION REPORT NO. 50-423/92-12(OL)

During the weeks of April 20 and 27, 1992, the NRC administered initial examinations to four Reactor Operator (RO) and two Senior Reactor Operator (SRO) candidates from your company who were applying for licenses to operate the Millstone Nuclear Power Station, Unit 3. These examinations addressed areas important to public health and safety and were administered under Revision 6 to the Examiner Standards (NUREG 1021). All six candidates, having passed the examination, will be issued licenses.

Concurrent with this examination, the NRC reviewed and closed four open items from the 1990 Emergency Operating Procedure Team Inspection (Report Number 90-80). Further explanation of these items is detailed in Section 5.0 of the attached report.

At the conclusion of the examination, generic issues that evolved as a result of the examination were discussed with those members of your staff identified in the enclosed report.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter and the enclosure will be placed in the NRC Public Document Room.
