SUBJECT: NRC REGION I REPORT NOS. 50-334/92-12 AND 50-412/92-08

This letter refers to the inspection by Mr. P. Patnaik on April 20-24, 1992 and Mr. H. Kaplan on April 27-30, 1992.

At the conclusion of the inspection, the findings were discussed by Mr. Kaplan and Mr. Patnaik with members of your staff.

The inspection included a review of various activities including eddy current examination of steam generator tubing, inservice inspection, and assessment of the welding program and other issues as discussed in the enclosed report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations of activities in progress. All of the areas inspected are considered important to ensuring the integrity of the plant. Although a Severity Level V violation was identified by the NRC, it is not being cited because immediate corrective action was taken by the licensee.

No reply to this letter is required. Your cooperation with us in this matter is appreciated.
