This is in response to the following Pennsylvania Power and Light Company correspondence regarding changes to the Susquehanna Safeguards plans:

- Letters dated December 2, 1983 and February 21, 1984 regarding Change Nos. Q and R to the Physical Security/Contingency Plan.
- Letter dated March 12, 1984 regarding Change No. C to the Security Training and Qualification Plan.

We have reviewed the information contained in these plan revisions and have determined that portions of these revisions are consistent with the provisions of 10 CFR 50.54(p), and are considered acceptable.

However, a certain portion of these revisions is not considered acceptable for the reasons stated in the enclosure to this letter. For this portion, you are to revert to previously approved plan wording and submit a corrected page revision to this office within 30 days of the receipt of this letter.

The enclosures to your above referenced letters and the enclosure to this letter are being withheld from public disclosure since they contain Safeguards Information and information of a type specified in 10 CFR 2.790(d) and must be protected in accordance with provisions of 10 CFR Part 73.21 or subject to disclosure only in accordance with the provisions of 10 CFR 9.12.


