# Examination Report 50-277/96-02 and 50-278/96-02 (OL)

Initial simulator retake examinations were administered to three senior reactor operator (SRO) applicants on January 18, 1996, at the Peach Bottom Atomic Power Station, Units 2 and 3. All applicants passed the examination.

### DETAILS

### 1.0 INTRODUCTION

The NRC administered initial simulator retake examinations to three senior reactor operator (SRO) applicants. The examinations were administered in accordance with NUREG-1021, "Examiner Standards," Revision 7.

### 2.0 PREEXAMINATION ACTIVITIES

The simulator scenarios were validated on January 17, 1996, on the facility's simulator. The facility staff who were involved with these reviews signed security agreements to ensure that the initial examinations were not compromised.

## 3.0 EXAMINATION RESULTS AND RELATED FINDINGS, OBSERVATIONS AND CONCLUSIONS

### 3.1 Examination Results
