This refers to the special safety inspection conducted by Mr. T. L. Harpster of this office on July 9 - 13, 1984, at the Indian Point Nuclear Generating Station Unit 3, Buchanan, New York, of activities authorized by NRC License No. DPR-64 and to the discussions of our findings held by Mr. Harpster with Mr. J. Brons and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
