This is Mississippi Power & Light Company's (MP&L's) final response to IE Bulletin No. 83-07, "Apparently Fraudulent Products Sold by Ray Miller, Inc." In our previous response [Reference (2)] we provided a status of our investigation and requested an extension until August 17, 1984 to allow our architect engineer (Bechtel Power Corporation) additional time to complete their investigation.

Based on investigations conducted by MP&L and both of our prime suppliers, General Electric and Bechtel Power Corporation, no Ray Miller, Inc. products have been purchased for use or installed in safety-related systems at Grand Gulf Units 1 and 2.

Six suppliers of nonsafety-related materials and equipment were unable to affirm if Ray Miller products were supplied to GGNS Units 1 and 2. The materials and equipment supplied by these six suppliers were evaluated in accordance with IE Bulletin No. 83-07 which refers to GDC 1 to 10CFR50, Appendix A. The evaluation concluded that since all the equipment and materials that can possibly contain Ray Miller products perform nonsafety-related functions, any failure should not impact plant safety nor compromise the health and safety of the public. Therefore, no further action is required.

Three Grand Gulf suppliers were identified in Attachment 2 to Supplement No. 1 of IE Bulletin No. 83-07. All three suppliers have affirmed that they supplied no Ray Miller products to GGNS Units 1 and 2.






