Dear Mr. Williams:

Enclosed is a copy of the proposed revisions to the Colorado Rules and Regulations Pertaining to Radiation Control, 6 CCR 1007-1, Part 17 (Transportation of radioactive material), and Part 22 (Physical protection of category 1 and category 2 quantities of radioactive material). The proposed revisions will be made available for public comment on or about April 7, 2020 with a request for comments on or before May 8, 2020. We request NRC's comments by May 22, 2020 in preparation for a June rulemaking request before the Colorado Board of Health. The proposed regulations are identified by srike-out/bold text and correspond to the following equivalent amendments to NRC's regulations.
