Gentlemen:

Enclosed for your review, prior to our scheduled meeting of September 18, 1984, is the SALP Board Report for the Kewaunee Nuclear Plant, covering the period April 1, 1983 through June 30, 1984.

Overall, during the report period, your performance was found to be good and generally showed an improving trend, with improvements noted in the ratings for Plant Operations, Radiological Controls and Surveillance.

Your ratings in the Plant Operations and Surveillance areas improved from a Category 2 to 1 due primarily to increased management initiative and controls. Additionally, Radiological Controls improved from a Category 2 to 1 rating based on the marked increase in the confirmatory measurements agreements and the strengthening of the Quality Control Program.

While you will have sufficient opportunity to present your comments at the meeting on September 18, we also solicit written comments within 30 days after the meeting to enable us to thoroughly evaluate your comments and provide you with our conclusions relative to them.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the SALP Report will be placed in the NRC's Public Document Room.

No reply to this letter is required at this time; however, should you have any questions concerning the SALP report, we would be pleased to discuss them with you.
