This refers to the routine safety inspection conducted by Mr. R. L. Nimitz and Mr. J. J. Kottan of this office on July 22-27, 1984 at the Susquehanna Steam Electric Station, Units 1 and 2, Berwick, Pennsylvania, of activities authorized by NRC License Nos. NPF-14 and NPF-22 and to the discussions of our findings held by Mr. Nimitz and Mr. Kottan with Mr. H. Keiser of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the violation brought to your attention in the enclosure to our letter dated December 22, 1983. We have no further questions regarding your action at this time.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1).
