Dear Ms. Donahue:

Enclosed is Amendment No. 12 to your NRC Materials License No. 24-00513-37 in accordance with your request. Please note that we did not delete the location of use located at 4747 Troost Avenue, Kansas City, Missouri listed in License Condition 10.E. In order to remove a separate building which had been used with licensed material authorized under the license (including unsealed licensed material with half-life more than 120 days), we will need information regarding the decommissioning of the site that discusses in NUREG-1757, Volume 1, "Consolidated Decommissioning Guidance: Decommissioning Process for Materials Licensees", Revision 2. The information should include the site usage history (isotopes were used, the maximum quantity was used, sealed and/or unsealed material, licensed activities, history of spills and/or contaminations, history of disposal via sinks and/or drains, any physical modifications to the used areas, etc.) Additionally, we did not delete the location of use located at 2464 Charlotte Street, Kansas City, Missouri listed in License Condition 10.B. because licensed material and use are still on going in the building.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. You can access the policy statement and supporting material that may benefit your organization on NRC's safety culture
