The purpose of this modification is to provide incremental funding in the amount of \$17,000.00 which increases the obligated amount from \$50,628.00 to \$67,628.00. Accordingly the contract is revised as follows:

Under Section B.4 CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988), paragraph b. the first sentence is deleted in its entirety and replaced with the following in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$67,628.00."

All other terms and conditions under the subject contract remain unchanged, including the ceiling amount of \$101,742.50.
