SUBJECT: NRC REGION 1 INSPECTION REPORT NOS. 50-334/92-13 AND 50-412/92-12

This letter transmits the report of the resident safety inspection by Mr. L. Rossbach and Mr. P. Sena at the Beaver Valley Power Station in Shippingport, Pennsylvania. The reporting period covers from April 19 to May 25, 1992. The inspection consisted of document reviews, interviews, and observation of activities important to public health and safety. The findings were summarized and discussed with Mr. T. Noonan and other members of your staff at the conclusion of the inspection.

Overall the plants were operated safely and conservatively. However, a weakness was identified regarding supervisory review of a maintenance work request which led to a safety injection at Unit 2.

Also, you identified an instance of failure to start a condensate pump in accordance with plant procedure, which resulted in an engineered safety feature actuation. This violation is not being cited because the criteria in Section VII.B of the Enforcement Policy were satisfied. The NRC considers the initiative of looking for, identifying, and correcting violations to be positive and encourages it.

Your researching with us is appreciated.
