SUBJECT: COOPER (CNS) EXAMINATION REPORT NO. 50-298/OL 92-01

During the week of May 18, 1992, NRC administered examinations to three employees of your company who had applied for licenses to operate your Cooper Nuclear Station facility, as well as requalification reexaminations to two individuals. All of the initial applicants passed all parts of their examinations and have been issued the appropriate license. Both of the requalification reexaminees also passed and have been issued letters documenting this for license renewal purposes.
