Subject: Request for Additional Information - QA for Startup
at Braidwood Station

Commonwealth Edison's letter of August 7, 1984, advised the NRC of its decision to organize and implement a project startup organization at Braidwood. Enclosures to this letter, which are to be incorporated into Chapters 13 and 14 of the Braidwood FSAR, explain the project startup organization.

The letter refers to Commonwealth Edison's "proven and fully accepted QA structure". The enclosures also mention QA: the Project OAD Supervisor is required "to be acquainted with the relevant quality assurance aspects of a nuclear facility;" the Project Material Coordinator is to obtain information "within the framework created by the approved CECO QA program;" and participants of test review boards are to be assigned "consistent with the requirements of the Quality Assurance Manual." Neither the letter nor its enclosures address the authority, activities, and responsibilities of Commonwealth Edison's QA and QC organizations in light of the project startup organization, nor do they address interface relationships between the project startup organization and the QA and QC organizations.
