This refers to the Nuclear Regulatory Commission (NRC) administered requalification examinations led by J. Moorman during the weeks of May 4 and May 11, 1992. These examinations were administered to employees of your company who currently hold licenses to operate the Catawba Nuclear Station. At the conclusion of these examinations, the examination questions and preliminary findings were discussed with those members of your staff identified in the Examination Report, Enclosure 1.

NRC operator requalification exams were previously administered to operators of your facility in April 1991. This exam identified operator weaknesses in procedure usage, particularly the use Emergency Operating Procedures. Our examination report dated May 30, 1991, identified these weaknesses as similar to weaknesses identified in the previous NRC administered requalification examination. Your management was invited to the Region II office to discuss Emergency Operating Procedure requirements and the effectiveness of training in this area. At this meeting, Catawba management told the NRC that improvements would be made.

During this year's requalification exam, the examiners noted weaknesses in procedure usage, Emergency Operating Procedure content, and operator training methodology that indicate some of your operators would have difficulty mitigating an accident. These findings are similar to those identified during the above mentioned exams and are consistent with the recent performance of personnel in your operations department that resulted in a civil penalty being issued by the NRC

The continued pure performance of the operators, particularly with respect to procedure usage, is indicative of a lack of effectiveness of Operations management in ensuring procedure adherence. It is also indicative of a lack of Operations management support for requalification training of the operators and the function of the training program. We feel that comprehensive corrective actions to address the problems described in this report are warranted. Accordingly, you are invited to respond to this report in writing within 30 days describing those corrective actions.
