On performing Technical Specification surveillance procedure 7.4.1.4.2 on 8/18/84 to verify proper indication of rod selection error, it was noted that the Rod Worth Minimizer (RWM) did not initiate a select error in the transition zone when an out of sequence rod was selected. A procedure deviation was written which deleted portions of the procedure which verified this select error signal. Thus the surveillance requirement of 4.1.4.1.a could not be performed. Since the surveillance procedure no longer required "SELECT ERROR" verification, it was not recognized that surveillance requirement 4.1.4.1.a was not being met. Thus the RWM was not declared inoperable and a second licensed operator was not stationed to observe rod movement and pattern.

Immediate Corrective Action

None

Further Corrective Action

A Plant Modification Request has been generated to provide the capability to verify proper indication of the select error for out-of-sequence control rods.

The procedure deviation has been cancelled by the Plant Operations Committee and individuals involved in generating the deviation counseled on the correct application of deviations.

This LER will be included as mandatory reading for all Shift Managers and Control Room Supervisors.

Safety Significance

There were no safety consequences associated with this event. In fact, the RWM was operable at all times per design during this event and rod movement followed the perscribed pattern.
