In a telephone conversation on January 22, 1996, Mr. J. Prell and Mr. R. Hess made arrangements for the NRC to inspect the licensed operator requalification program at the Three Mile Island facility. The inspection is planned for the week of March 11, 1996, which coincides with your regularly-scheduled requalification examination cycle. The staff at your facility should prepare and conduct the requalification examinations in accordance with your NRCapproved requalification program.

In accordance with 10 CFR 55.59(c), the NRC may request facility licensees to submit their comprehensive requalification written examinations or annual operating tests as necessary to support the NRC's inspection program needs. In order for the NRC to adequately prepare for this inspection, please furnish the written examinations and operating tests scheduled for the week of the inspection to the NRC by February 28, 1996. Mr. Hess has been advised of this request and provided with the name and address of the NRC lead inspector assigned to this inspection.

The request for requalification examination material is covered by the Office of Management and Budget (OMB) Clearance Number 3150-0101, which expires on April 30, 1997. The estimated average burden is 4.0 hours per response, including gathering, copying, and mailing the required material.
