SUBJECT: NRC INSPECTION REPORT NO. 50-285/92-11 (NOTICE OF VIOLATION)

This refers to the inspection conducted by Messrs. R. Mullikin and R. Azua of this office on April 26 through June 6, 1992. The inspection included a review of activities authorized for your Fort Calhoun Station facility. At the conclusion of the inspection, the findings were discussed with you and those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the enclosed report. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations of activities in progress.

Within the scope of this inspection certain of your activities was in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). This violation is a concern because it shows ineffective corrective action to a previous event.

You are required to respond to this letter and should follow the instructions in the enclosed Notice when preparing your response. In your response you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR Part 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.


