REVISION OF PREVIOUS REQUEST TO CHANGE TECHNICAL SPECIFICATIONS

Gentlemen:

Our letter of May 4, 1984 requested a Technical Specifications change for Hatch Unit 1 which would expand the definition of "Operability" (as requested by NRC) to include functionality of support equipment. We now request that the shutdown requirements of the previously requested definition be amended. Additionally, the page submitted was incorrectly identified as a Unit 2 Technical Specification page. We therefore wish to amend our submittal of May 4, 1984 to replace the previously submitted Technical Specification page (incorrectly identified as page 1-4), with the enclosed page 1.0-3.

The shutdown requirement contained in the May 4, 1984 submittal has been revised to call for entering the Hot Shutdown condition in 12 hours instead of specifying Hot Standby in 6 hours and Hot Shutdown in the next 6 hours. This allows consistency with other Limiting Conditions for Operation and provides more operational flexibility. No other changes have been made to the content of the previous submittal.

The Plant Review Board has determined that the proposed revisions to our previous submittal do not constitute an unreviewed safety question. The revised shutdown requirement does not affect probabilities or consequences of analyzed accidents. No new accident types are created. The margin of safety is not affected.

The safety evaluation and determination of no significant hazards enclosed with our May 4, 1984 submittal remain valid.




