Gentlemen and Mesdames:

This letter is being written at the direction of the Licensing Board Chairman in this proceeding, in lieu of the issuance of a Board Order.

A telephone conference call was held on September 12, 1984, with regard to the "NRC Staff's Motion for Extension of Time" filed on September 11, 1984, and responses thereto filed by LILCO and Suffolk County. The following proposal was advanced jointly by LILCO, Suffolk County, the State of New York, and the NRC Staff, with respect to the schedule for filing responses to "LILCO's Motion for Summary Disposition of Contentions 1-10 (The 'Legal Authority' Issues)," filed on August 6, 1984:

- September 24, 1984 Responses to be filed by Suffolk County and the State of New York (to be received by the NRC Staff by 5:00 p.m.)
- October 4, 1984 Response to be filed by the NRC Staff
- October 15, 1984 Reply to be filed by LILCO

The schedule proposed by the parties, as set forth herein, was considered and approved by the Licensing Board Chairman.
