This refers to the routine resident safety inspection by Messrs. J. Linville and R. Summers on July 7, 1984 - August 13, 1984 at the Salem Nuclear Generating Station, Hancocks Bridge, New Jersey. The inspection consisted of document reviews, interviews, and observation of activities. The findings were discussed with Mr. J. M. Zupko, Jr. of your staff.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (47 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
