Gentlemen:

This refers to the inspection conducted by Mr. J. L. Montgomery of this office during the period July 16-20, 1984, of activities authorized by NRC Construction Permit CPPR-145 for the River Bend Station, and to the discussion of our findings with you and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included emergency preparedness program development status for the emergency organization, training, emergency facilities, and coordination with offsite groups. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter.
