Georgia Power Company is conducting cultural resource management planning actions for a transmission line under construction between the Vogtle Electric Generating Plant (VEGP-Burke County, Georgia) and the R. W. Scherer Electric Generating Plant (Scherer-Monroe County, Georgia). Garrow and Associates, Inc., has completed a resource inventory and assessment study for a 56.4 mile section of that line, known as the Wadley to Wallace Dam Section. A copy of their final report is enclosed.

Garrow and Associates has identified one cultural property listed on the National Register of Historic Places and twenty-five (25) which they recommend as eligible for listing therein. Thus, a total of twenty-six (26) properties are recommended for management consideration by Georgia Power Company.

Georgia Power Company has assessed resource treatment alternatives for the twenty-six (26) properties. A copy of a tentative resource treatment plan for those properties is also enclosed. This plan discusses resource management planning activities to date and sets out Georgia Power Company's intentions with regard to the management of those properties.
