Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the NRC inspectors. The inspection findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

Based on the unusually prompt and extensive corrective actions taken when very high radiation (VHR) area doors were found shut but not latched (locked shut), no violation was issued. However, since the end of this inspection period another VHR door has been found unsecured indicating that previous corrective actions have not been fully effective.
