This refers to the routine safety inspection conducted by Dr. Richard K. Struckmeyer of this office on July 23-27, 1984 at the Beaver Valley Power Station, Shippingport, PA of activities authorized by NRC License No. DPR-66 and to the discussions of our findings held by Dr. Richard K. Struckmeyer with Mr. J. Kosmal and others of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.
