This refers to the inspection conducted by Messrs. T. W. Dexter and A. B. Earnest of this office on May 4-8, 1992. The inspection included a review of activities authorized for your Wolf Creek Generating Station facility. At the conclusion of the inspection, the findings were discussed with Mr. Brad Norman and other members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. These included selective examination of procedures and representative records, interviews with personnel, and observation of activities in progress.

Within the scope of the inspection, no violations or deviations were identified. One concern was identified involving vital area barriers. The concern and your commitment to resolve this matter are discussed in paragraph 3.2.2. of the enclosed inspection report. Please inform us if your understanding of the commitment is different than stated in the report.

We have also examined actions you have taken with regard to previously identified inspection findings. The status of these items is identified in paragraph 2 of the enclosed report.


