
VOGTLE ELECTRIC GENERATING PLANT  
PHYSICAL SECURITY AND CONTINGENCY PLAN  
AMENDMENT 22 CORRECTIONS

Georgia Power Company (GPC) submitted Amendment 22 of the Vogtle Electric Generating Plant Physical Security and Contingency Plan per 10 CFR 50.54(p) on March 31, 1992. The NRC reviewed the submitted revision and found most of the items revised to be consistent with the provision of 10 CFR 50.54(p). However, in the letter of April 28, 1992, the NRC requested one clarification to Section 5.1.3, "Access Authorization." In response to this request GPC has added the statement "All elements of Regulatory Guide 5.66 have been implemented to satisfy the requirements of 10 CFR 73.56." In addition to this clarification GPC also resubmits correction pages for the Table of Contents and Security Organizational Chart.

Enclosure 1 contains insertion instructions for the above mentioned clarification and corrections. Enclosure 2 contains the new Security Plan Amendment 22 revised pages, and enclosure 3 contains the new effective page list.

The information contained in enclosure 2 is safeguards information and should be withheld from public disclosure in accordance with 10 CFR 73.21. Please contact this office if you have any questions.
