Furnished herewith for your review and approval is a revised copy of Change Notice 90-10 to the Callaway Plant Operating Quality Assurance Manual (OQAM) consisting of the following:

1. OQAM (Change Notice 90-10) mark-up, identifying changes through the use of inserts and strikeouts.
2. Explanations and justifications for changes to the OQAM.

Changes have been made from our reference 2 submittal as a result of discussions between J. C. Gearhart and the NRC staff. This submittal replaces our January 3, 1992 submittal in its entirety.

The purpose of the revision is to allow processing of QA originated corrective action documents consistent with all similar documents. The specific changes include a rewrite of OQAM Section 16 to improve user understanding when preparing implementing procedures for corrective action, and deletion of in-line QA approval of specific responses and verification of actions to correct deficiencies.
