- On 8-21-84 the photocell (MDA Scientific, Inc., Part #744306) in WOA-SR-15 began to fail giving a false Hi Chlorine signal which tripped the Emergency Filtration System. Troubleshooting began on the unit but nothing specific was found. The detector was cleaned and put back in service.
- 2) On 8-24-84 another spurious Hi Chlorine signal started the Emergency Filtration System. During troubleshooting the photocell was found to be faulty. Further work determined that the reason for the photocell failure was the excessive temperature in the detector cabinet. The ppm chlorine reading was found to vary when the cabinet was left open and cooling was increased.

Immediate Corrective Action

The photocell in WOA-SR-15 was replaced and the detector cabinet fans for both WOA-SR-15 and 16 were supplied with temporary power to provide the required cooling.

Fucure Corrective Action

A Plant Modification Request has been submitted asking for direction to permanently connect the detector cabinet fans to the power supply for the detectors. This request is being tracked to completion in the Plant Tracking Log.

Safety Significance

...

This event has no safety significance as all equipment operated correctly to place the Control Room Ventilation System in an isolation configuration.
