S5G REACTOR COMPARTMENT DISPOSAL PACKAGE - SAFETY ANALYSIS REPORT FOR PACKAGING (DOCKET NO. 71-9788); RESPONSE TO NRC REQUEST FOR ADDITIONAL INFORMATION

Background: Reactor Compartment Disposal Packages (RCDPs) are shipping containers for radioactive material, manufactured by modifying the reactor compartments of decommissioned nuclear powered vessels. The RCDP is certified as a Type B package for shipment of fissile and highly radioactive material. Title 10, Code of Federal Regulations, Part 71 (10CFR71) delineates federal requirements for shipping Type B packages. Compliance with 10CFR7I is demonstrated through a Safety Analysis Report for Packaging (SARP). In letter Z#C19-03241 dated August 5, 2019, Naval Reactors forwarded a SARP for the S5G RCDP to the Nuclear Regulatory Commission (NRC) for review and concurrence. In response, NRC requested additional information in a letter dated December 23, 2019.
