This refers to the Preoperational Security Program Review inspection conducted by Mr. R. J. Bailey of this office on July 23-24 and 26-27, 1984 at the Limerick Generating Station, Limerick, Pennsylvania of activities authorized by NRC License No. CPPR-106 and to the discussions of our findings held by Mr. Bailey with members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.

A section of the enclosed inspection report contains details of your security program that has been determined to be exempt from public disclosure in accordance with either 10 CFR 73.21 (Safeguards Information) or 10 CFR 9.5(a)(4) (Commercial or Financial Information). Therefore, the section so identified in the inspection report will not be placed in the NRC Public Document Room and will receive limited distribution. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1).
