Gentlemen:

Enclosed are Revisions 4, 5 and 6 to the Beaver Valley Power Station Physical Security Plan (PSP). These changes are as follows:

- Rev. 4, Base Plan, Page 1-1 and Figure 1-1, reflected corporate reorganization changes which established the General Manager, Nuclear Services Unit as having security organization responsibilities.
- Rev. 4, Contingency Plan, Page 8-4 established an event response matrix for security force or site employees strike.
- Rev. 5, Base Plan, Pages 1-1 and 1-2 and Figure 1-1, reflected additional reorganization changes which added the Manager, Administrative Services to the management organization for security.
- Rev. 6, Base Plan, Page 3-1 and Figure 3-1a, reflects temporary structures, primarily construction and fourth refueling outage support facilities.

The changes in Revision 4, 5 and 6 have been reviewed and judged not to constitute a degradation to the previous commitments in the PSP.

These changes, since they do not decrease the safeguards effectiveness of the Physical Security Plan, are being submitted in accordance with 10CFR50.54(p).


