Napuda of this office on June 4-8, 1984 at the Millstone Nuclear Energy Station, Unit 3, Waterford, Connecticut of activities authorized by NRC License No. CPPR-113 and to the discussions of our findings held by Mr. Napuda with Mr. D. Miller, Jr. and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter.
