Steiger and other members of your staff at the conclusion of the inspection, and to subsequent telephone discussions between Mr. Blumberg and Mr. G. Rhoads a consultant to your staff and Mr. J. Alexander of your staff on August 2 and 3, 1984 respectively.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no items of noncompliance were observed. However, one activity appears to be a deviation from your commitments as stated in the Final Safety Analysis Report (FSAR), as set forth in the Notice of Deviation, enclosed herewith as Appendix A. In your response please follow the instructions of Appendix A.
